# **GENERAL INFORMATION**

DISPATCH INJECTABLE improves the infiltration and penetration of applied water, and can be applied to all fine turf. DISPATCH INJECTABLE is formulated to be applied through irrigation systems. For application by conventional spray rig equipment, use DISPATCH SPRAYABLE.

Improvements in moisture content are most notable during periods of moisture stress.

# DIRECTIONS FOR USE

**Turf:** Turfgrass grown on soils such as those found on golf courses and athletic fields.

#### **Application Rates and Frequency**

For best results inject 1-2 L per hectare (12-24 fl oz per acre) on a weekly basis. For more difficult areas, DISPATCH INJECTABLE may be applied at 3.6 L per hectare (48 fl oz per acre).
