USE RATES

0.25%-0.50% v/v (2-4 pints) of Border 2.0 per 100 gallons of spray solution.

MIXING

Fill the sprav tank with at least 50% of the desired finished carrier volume. **Do not** pre-mix Border 2.0 in a mixing vessel or inductor. While the carrier is agitating, add tank mix ingredients in the following order:

- 1. Compatibility agent and/or antifoam, if needed
- 2. AMS, dry formulations (WP, DF, WDG, SP)
- 3. Dry soluble and suspension fertilizers / micronutrients
- Flowable formulations (F & FL) 4.
