## 2. HAZARDS IDENTIFICATION SUMMARY

## 4. FIRST AID MEASURES

## 5. FIRE FIGHTING MEASURES

## 6. ACCIDENTAL RELEASE MEASURES

### STEPS TO BE TAKEN IF MATERIAL IS RELEASED OR SPILLED:

For small spills, absorb with an absorbent material such as sand, vermiculite or other absorbent material. Place contaminated material in appropriate containers for proper disposal. For large spills: dike large spills using absorbent or impervious material such as clay or sand. Recover and contain as much free liquid as possible for reuse. Allow absorbed material to solidify, and scrape up for disposal. After removal, scrub the area with detergent and water and flush contaminated area thoroughly with water.

**CAUTION:** Keep spills and cleaning runoff out of municipal sewers and open bodies of water.

**7. HANDLING AND STORAGE**

---

**HANDLING:** Wash hands before eating, drinking, chewing gum, using tobacco or using the toilet. Remove clothing immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing. Remove PPE immediately after handling this product. Wash the outside of gloves before removing. As soon as possible, wash thoroughly and change into clean clothing.

**STORAGE:** Keep container tightly closed when not in use. Do not store near seeds, fertilizer, or foodstuffs. Can be stored at temperatures as low as -30°F / -34.4°C. Do not contaminate water, food, or feed by storage or disposal.

**Personal Protective Equipment (PPE): Applicators and other handlers must wear:** coveralls over long sleeved shirt and long pants, chemical-resistant gloves, chemical-resistant footwear plus socks, protective eyewear, chemical-resistant headgear (if overhead exposure), and a chemical-resistant apron when cleaning equipment, mixing, or loading, or otherwise exposed to the product's concentrate. Discard clothing and other absorbent materials that have been drenched or heavily contaminated with this product's concentrate. Do not reuse them. Follow manufacturer's instructions for cleaning and maintaining PPE. If no instructions for washables, use detergent and hot water. Keep and wash PPE separately from other laundry. **STABILITY:** Stable

**INCOMPATIBILITY:** None known.

**11. TOXICOLOGICAL INFORMATION**

---

**Acute Oral LD<sub>50</sub> (male rat):** 2000-5000 mg/kg

**Eye Irritation (rabbit):** Slight irritant

**Inhalation LC<sub>50</sub> (rat):** >6.29 mg/L (4 hrs.)

**Acute Dermal LD<sub>50</sub> (rabbit):** >5000 mg/kg

**Skin Irritation (rabbit):** Slight irritant

**Skin Sensitization (guinea pig):** Acetochlor and Dichlormid have caused sensitization.

**Carcinogenic Potential:** Acetochlor has caused cancer in laboratory animals. Atrazine is listed as TLV-A4 by ACGIH (Not Classifiable as a Human Carcinogen) and 3 (Unclassifiable as to Carcinogenicity in Humans) by IARC; nothing listed in NTP, or OSHA.

**12. ECOLOGICAL INFORMATION**

---

This pesticide is toxic to fish and aquatic invertebrates. Do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean high water mark. Do not apply when weather conditions favor drift from treated areas. Runoff and drift from treated areas may be hazardous to aquatic organisms in neighboring areas. Do not contaminate water when disposing of equipment wash waters. Acetochlor has properties that may result in surface water contamination via dissolved runoff and runoff erosion. Practices should be followed to minimize the potential for dissolved runoff and/or runoff erosion. Atrazine can travel (seep or leach) through soil and can enter groundwater which may be used as drinking water. Atrazine has been found in groundwater. Users are advised not to apply Atrazine to sand and loamy sand soils where the water table (groundwater) is close to the surface and where these soils are very permeable, i.e. well-drained.

**13. DISPOSAL CONSIDERATIONS**

**Container Disposal: Nonrefillable container.** Do not reuse this container to hold materials other than pesticides or dilute pesticides (rinsate). After emptying and cleaning, it may be allowable to temporarily hold rinsate or other pesticide-related materials in the container. Contact your state regulatory agency to determine allowable practices in your state. Once cleaned, some agricultural plastic pesticide containers can be taken to a container collection site or picked up for recycling. To find the nearest site, contact your chemical dealer or manufacturer, or contact The Agricultural Container Recycling Council (ACRC) at [www.acrecycle.org](http://www.acrecycle.org). Triple rinse or pressure rinse container (or equivalent) promptly after emptying. **For packages up to 5 gallons: Triple rinse as follows:** Empty the remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container ¼ full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. **Pressure rinse as follows:** Empty the remaining contents into application equipment or a mix tank and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over application equipment or mix tank or collect rinsate for later use or disposal. Insert pressure rinsing nozzle in the side of the container, and rinse at about 40 PSI for at least 30 seconds. Drain for 10 seconds after the flow begins to drip. **For packages greater than 5 gallons and less than 56 gallons: Triple rinse as follows:** Empty the remaining contents into application equipment or a mix tank. Fill the container ¼ full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. **Pressure rinse as follows:** Empty the remaining contents into application equipment or a mix tank and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over application equipment or mix tank or collect rinsate for later use or disposal. Insert pressure rinsing nozzle in the side of the container, and rinse at about 40 PSI for at least 30 seconds. Drain for 10 seconds after the flow begins to drip. **For packages greater than 56 gallons:** To clean the container before final disposal, empty the remaining contents from this container into application equipment or mix tank. Fill the container about 10 percent full with water. Agitate vigorously or recirculate water with the pump for 2 minutes. Pour or pump rinsate into application equipment or rinsate collection system. Repeat this rinsing procedure two more times. **For refillable containers:** Refill this container with pesticide only. Do not reuse this container for any other purpose. Cleaning the container before final disposal is the responsibility of the person disposing of the container. Cleaning before refilling is the responsibility of the refiller. To clean the container before final disposal, empty the remaining contents from this container into application equipment or mix tank. Fill the container about 10 percent full with water. Agitate vigorously or recirculate water with the pump for 2 minutes. Pour or pump rinsate into application equipment or rinsate collection system. Repeat this rinsing procedure two more times. Pesticide wastes are toxic. Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility. Improper disposal of excess pesticide, spray mix, or rinsate is a violation of Federal law. Do not contaminate water, food, or feed by storage or disposal.
